The Lake Washington PTSA Council is pleased to offer LWSD Certificated Staff two professional development scholarships of \$500 each, to be used beginning July 1, 2021. To be eligible to apply for these scholarships, applicants must be a current certificated LWSD staff member upon date of submission. Scholarships are to be used only for: continuing education at an institute of higher learning; through the LWSD staff development department; or the National Board Certification program. The LWPTSA Council is an organization that advocates on behalf of children and we are looking for certificated staff members who want an opportunity to enhance their education to benefit all students.

Recipients will be announced by June 1, 2021. All granted funds must be requested by the recipients for use prior to January 31, 2022. Funds are paid by LWPTSA directly to the approved school/vendor the awardee designates. Funds not paid out prior to January 31st, 2022 will remain in the LWPTSA Scholarship Fund to be carried forward.

The Scholarship Committee will award staff scholarships based on the following criteria:

1. Application must meet stated requirements and be returned by the deadline.
2. Priority will be given to applicants who best convey how a scholarship will help them directly apply a course of study to their roles as certificated LWSD staff members, helping them better meet the needs of students both in the classroom and in the school as a whole.
